

ATTENDANCE POLICY #1

- I. NO MEETINGS SHALL BE MISSED
- II. IF UNABLE TO ATTEND, CALL THE DESIGNATED PERSON BEFORE THE MEETING.
 - A. FAILURE TO CONTACT THE DESIGNATED PERSON BEFORE THE MEETING WILL RESULT IN AN UNEXCUSED ABSENCE.
 - B. THERE WILL BE NO EXCUSES ACCEPTED AFTER THE MEETING. AS WELL, NO OTHER MEMBER SHALL BE RESPONSIBLE FOR INFORMING THE DESIGNATED PERSON ABOUT ANOTHER PERSON'S ABSENCE.
- III. THE ONLY ACCEPTABLE EXCUSES
 - A. MASONIC EVENTS SUCH AS: MEETINGS, INSTALLATIONS, AND PRACTICES. RAINBOW RECEPTIONS FOR ONLY THOSE WHO ARE GRAND OFFICERS AND ONE TRAVELING COMPANION OR PERSONS RUNNING FOR A GRAND OFFICE AND ONE TRAVELING COMPANION. NO EXCUSE MAY BE USED FOR AN ASSEMBLY PARTY UNLESS YOU ARE WORTHY ADVISOR OF THE ASSEMBLY OR THE HONOREE.
 - B. ACADEMIC EXCUSES ARE AS SUCH. FIELD TRIPS, TWO EXAMS THE NEXT DAY, OR REQUIRED LECTURES.
 - C. ILLNESS
- IV. IF NO EXCUSE IS GIVEN BY A MEMBER WHO MISSES MEETINGS, SHE WILL BE PENALIZED.
 - A. SHE WILL BE FINED \$2.00 FOR EACH MEETING MISSED AND ANY SOCIAL ACTIVITIES THAT ARE PLANNED AND ON THE CALENDAR DATE GIVEN AT BEGINNING OF SEMESTER.
 - B. THERE WILL BE A \$5.00 FINE FOR THOSE MANDATORY MEETINGS MISSED SUCH AS INSTALLATION, SISTERHOOD, AND CHAPTER PROJECTS (SERVICE PROJECTS).
 - C. THERE WILL BE A \$7.00 FINE FOR INITIATION AND PLEDGING IF THEY ARE MISSED. THESE TWO ARE MANDATORY ALSO.
- V. IF AN EXCUSE IS GIVEN OR IF NO EXCUSE IS GIVEN THE MEMBER WILL BE REQUIRED TO PAY THE SOCIAL FEES FOR THE NEXT SEMESTER. IF A MEMBER ATTENDS ALL MEETINGS AND FUNCTIONS THE SOCIAL FEE FOR THE NEXT SEMESTER WILL BE WAIVED.
- VI. THE VICE PRESIDENT AND SECRETARY WILL BE KEEPING ATTENDANCE. THIS ATTENDANCE RECORD WILL HAVE THOSE LISTED AT THE MEETING AND THOSE NOT. THOSE WHO ARE LISTED AS NOT IN ATTENDANCE WILL HAVE EXCUSED MARKED NEXT TO THEIR NAME IF AN EXCUSE IS GIVEN.
